Oxford Digital Theses

The University of Oxford is committed 'To share the fruits of research as widely as possible' (<u>University Strategic Plan 2013-18</u>, commitment 8) and to support this commitment, the Bodleian Libraries provides the Oxford University Research Archive (ORA), an institutional repository. ORA is an online archive of research output, including digital copies of theses created in fulfilment of University of Oxford awards. There are a number of benefits to storing your thesis in ORA including:

- Maximised visibility for you and your research
- Easy access to the full text of freely available theses
- **Persistent links** to your thesis which won't 'die' and which can be used when **citing** your thesis
- **Preservation** of the digital copy of your thesis.

D.Phil., M.Litt. and M.Sc.(by Research)

Students admitted on or after 1 October 2007 and successfully completing the D.Phil., M.Litt. and M.Sc.(by Research) programmes are required to deposit a print and a digital copy of their thesis with the Bodleian. Voluntary deposit

Students completing D.Clin.Psych, Doctor of Medicine, M.Phil., Master of Studies in Legal Research (M.St.) or Bachelor of Philosophy (B.Phil.) can voluntarily deposit a digital copy of their thesis into ORA. Oxford alumni are also invited to deposit a digital copy of their thesis in ORA.

Access to your thesis

For academic programmes requiring deposit of your thesis, the hardbound copy will be stored in the Bodleian Library. Visitors to the library will be able to read your thesis on site. Digital copies held in ORA will be made freely available via the Internet. Theses which have been granted dispensation from consultation or which are subject to embargo (see below) are unavailable to readers.

When to deposit

You should deposit your thesis to ORA after you have been granted **leave to supplicate (LTS)**, after examination.

What to deposit

The version of your work that is required for deposit to the research archive in order to comply with the terms of your graduation is a copy that is as close to the examined work as possible, with all images and text in place and no security settings applied for the purpose of preservation.

A PDF version of the work (which may be identical) should also be added to the archive as the version for dissemination (once any embargo periods have ended). For further information see: http://ox.libguides.com/what to deposit

How to deposit

Go to <u>http://ora.ox.ac.uk/</u>. Click on *Deposit* in the header and follow the instructions. See <u>http://ox.libguides.com/how_to_deposit</u> for guidance.

Dispensation from consultation

There may be good reasons why your thesis cannot be made publicly available. For example, it might contain confidential, sensitive or commercial information¹, infringe copyright², or there may be concerns about pre-publication³. If this is the case you should apply for dispensation from consultation using form GSO.3c

NB: ORA staff do not make the decisions with regards to the granting of dispensation, the decision is taken by the appropriate department and Graduate Studies Committee.

The restriction can be applied to the entire thesis or only to one or more sections of it. It may in extreme cases apply to the abstract or even the thesis record.

If you think your thesis should be subject to restricted access, you should check with your supervisor. Once dispensation from consultation has been granted, the period of restricted access should be indicated on the ORA online deposit form.

* Students following programmes which are eligible for voluntary deposit in ORA should not make sensitive material publicly available, but do not have to apply for formal dispensation from consultation. Further advice is available at: <u>http://ox.libguides.com/dispensation</u>

Default embargo

Under divisional policy your thesis file is subject to a default embargo, enabling you to pursue publishing all or part of your research as a printed monograph or journal article(s) should you wish, unless you inform ORA staff otherwise. If you want to extend the embargo on all or parts of your thesis beyond the initial period you will need to apply for dispensation from consultation. You may change access to your thesis to open access at any time during the embargo period, but should consult with your supervisor before doing this.

The current default embargo placed upon submitted theses to ORA, by Divisional policy, is three years. However if you are in receipt of funding from the Research Councils UK (RCUK) or another sponsor, the length of the embargo to be applied may be determined by the terms of your funding grant.

Please check the policy conditions if you are in receipt of a funding grant and advise ORA as to what embargo length needs to be attributed to your work.

Publication of your thesis

Making your thesis freely available in ORA constitutes a form of publication. Your thesis will be made available online following a default embargo period unless you have opted for immediate open access or have been granted dispensation from consultation to extend the embargo on your thesis.

The copyright of your thesis

Copyright in the thesis usually rests with the author: this does not change when depositing your thesis in ORA. The author does not give away any rights to the Oxford University Research Archive or the Bodleian Libraries. In a minority of cases, copyright might rest with a sponsor or other body. Please speak to your supervisor or Research Services if you are unsure.

Third Party copyright

Third party copyright refers to copyright works created by someone other than yourself. If you have incorporated material within the thesis where copyright is held by an individual or group that is not the author you will need permission to make such material freely available on the Internet. It is best to obtain permission when sourcing the material. You need to provide proof of permission when depositing your thesis in ORA (e.g. email or letter). Creating an edited version of your thesis

If you are unable to make the full version available online you may decide to make a separate edited version publicly available (as opposed to splitting the thesis into a number of files and embargoing the files containing copyrighted material). If this is the case you should save an additional copy of your thesis, **remove** the relevant material and insert a place holder at this point in the document.

Where an edited version is to be made available dispensation for the removed content should be applied for. <u>http://ox.libguides.com/dissemination_version</u>

Consent from research participants

You will need consent from research participants for the inclusion of their personal data in your thesis, to ensure compliance with data protection legislation and also to address any concerns about the publication of sensitive or confidential information. For particularly sensitive material, you may wish to seek consent for publication in an appendix to which access is restricted. Sample wording explaining about online deposit is available on the CUREC website (www.admin.ox.ac.uk/curec) to include in participant information.

Intellectual property rights

If consultation or reproduction of all or part of the thesis would put at risk *confidential material* or invalidate an application for a *patent* on a product or process described in the thesis, or restricting access to the thesis is a requirement of any *agreements with an outside body or sponsor* governing supply of confidential material or the disclosure of research results described in the thesis, you should apply for dispensation from consultation. Please speak to your supervisor or Research Services for advice.

Fonts and images

Many authors need to include non-Roman characters in their publications. Use of Unicode fonts is recommended for inclusion in ORA to allow for interchange and conversion in future. Modern office applications (e.g. MSWord) are usually Unicode compliant.

Many students want to include images within their thesis. General advice is to keep things as simple as possible. For help and information about many issues associated with images (such as format and rights), contact Bodleian Libraries Imaging Services who will try to help.

File size

The size of files which can be uploaded to ORA via the web deposit form has been limited to a maximum of 50Mb. This has been set for a number of pragmatic reasons, such as to ensure easy access and download of items in ORA.

Plagiarism

There is a widespread global trend to make theses open access. Making the thesis open access increases its visibility, gains recognition for the author and certifies them as author of the work. It can also give rise to concerns about increased risk of plagiarism.
