## Regular Giving: ongoing support for year-round need

Your regular gift provides a much more secure footing to plan ahead for the future and helps to ensure Oxford remains one of the very best places in the world to study, teach and carry out research. You can choose to contribute to the University Annual Fund which benefits the University as a whole, to an individual college, a specific department or Oxford institution such as the Bodleian Library, or another aspect of University life – sports, for example – with which you have a close affinity. With Direct Debits you can make payments when it suits you best: monthly, quarterly or annually.

### Direct Debit Guarantee

- This Guarantee is offered by all Banks and Building Societies that take part in the Direct Debit Scheme. The efficiency and security of the Scheme is monitored and protected by your own Bank or Building Society.
- If the amounts to be paid or the payment dates change, the University of Oxford Development Trust will notify you ten working days in advance of your account being debited or as otherwise agreed.
- If an error is made by the University of Oxford Development Trust or your Bank or Building Society, you are guaranteed a full and immediate refund from your branch of the amount paid.
- You can cancel a Direct Debit at any time by writing to your Bank or Building Society. Please also send a copy of your letter to us.

## Increase the value of your donations with Gift Aid

If you are a UK taxpayer, you can declare that all donations made on or after the date of this declaration should be treated as Gift Aid donations. Doing so maximises your gift because we can reclaim 25p for every £1 you donate at no further cost to you. If you pay higher rate tax, you can reclaim further tax relief on your tax return, (currently an additional 25p for every £1 you donate if you pay the higher rate of 40%, or an additional 37.5p if you pay the higher rate of 50%). You must pay an amount of Income Tax and/or Capital Gains Tax at least equal to the tax which the Trust Fund reclaims on your donation in the tax year (currently 25p for every £1 you donate). Please consider a Gift Aid donation wherever possible).

If your declaration covers donations which you may make in the future, please notify the Development Office if you change your name or address whilst the declaration remains in force. You may cancel the declaration by notifying the Development Office. The declaration will then not apply to donations you make on or after the date of cancellation, or such later date as you may specify. If you are unsure whether your donation qualifies for Gift Aid, we will be pleased to advise you. Please contact the Development Office at the address below.
